About organization

The Shibganj Integrated Development Society (SIDS) is registered as a "society" under the West Bengal Societies Registration Act XXVI of 1961 and registered under the Foreign Contribution (regulation) Act-2010, Ministry of Home Affairs, Govt. of India. It is registered under section 80G(5)(vi) of the Income Tax Act,1961 and Registered under section 12AA of the Income Tax Act, 1961 It is also registered under various Govt. and Non-govt. departments. SIDS has been working for the development of the needy and disadvantaged people of Sundarbans under the district of South 24 Parganas of West Bengal in India. It is non-profit making, non-govt., non-political and secular voluntary organization.

The organization was established on 01.04.2005. It has a proper constitution or articles of association. The organization has a properly constituted Executive body with its power and duties clearly defined in the constitution. It does not discriminate against any person or group of persons on the ground of sex, religion, caste or creed. It strives to provide opportunities for health, education and socio-economic development of the poor and downtrodden people with particular emphasis on differentially vulnerable groups like women, children, the rural poor and the berated youths towards the envisioned society. The authorities of the organization follow the rules and regulations of the Govt., VO and Donor Partners.

The organization has implemented various types of programs such as Sustainable Agricultural Development to ensure food security in the rural area, various vocational and handicrafts training for rural youths and women to make them self-reliant, establishment of Pre-Primary and Primary school for development of education of coastal poor infants, nutritional care for women and children as well as Reproductive Child Health and adolescents health, etc.

Genesis of the organization:

The organization was established on 1.4.2005. At the beginning in the year 2005, a few youths of the islands were witnessed the premature death of poor people due to starvation and hunger and a suicide case of a pregnant mother abused her husband. They were witnessed that the children of the poor family had to force to do of the illegal and sabotage works in the society due to their illiteracy, unawareness and poverty. These had promoted the youths to form an organization for making the people socially aware, spreading up the light of education among them and developing the economic status of the area.

Moreover, Mr. Subimal Karan a leading youth and present Secretary of SIDS realized from those incidents that unless the women are liberated from the gender based set up the total development of the community will remain mirage. Thus the youths formed the organization At first, it started its operation in two villages in PatharPratima block in South 24 Parganas.

Vision:

The society will be free from poverty, deprivation and unjust. It will be a self-reliant society based on human values like Cooperation, participation, justice, respect and love where people will participate in the decentralized political process, where the economy will be based on localized production and consumption, the environment will be free from pollution and exploitation, the people will survive with their own indigenous socio-cultural identity.

The first and foremost aim of SIDS is to build a sense of world brotherhood through nonviolence also it strives to provide opportunities for innovative health care, education, women empowerment, protection of human rights, socio-economic development of the poor and downtrodden people with particular emphasis on differentially vulnerable groups like women, children, adolescents, youths and person with disabilities.

The children belong to fishermen families, agricultural families, working class families, unschooling hereditary families, and very poor families. The organization is trying to reach the goal of providing quality organization to children.

Various projects implemented by the organization to provide health services to poor adolescents and mothers in coastal areas are Reproductive Child Health Care, Menstrual Health and Life Skills Education of adolescent girls, Community Health Development, Installation of Tube wells for safe drinking water, Construction of toilets, etc.

Our organization continues its efforts in environmental protection and conservation of biological diversity. It has implemented various types of programs in Sundarbans like a forestation, seminar and awareness camps, solid waste management, water resource management and Biotechnology oriented programs.

We believe that Agriculture is the basis of the village development. We have always prioritized agriculture among our goals. The program includes: Increasing sustainable farming practices among cultivators, supplying of agricultural minikits, organizing training programs, fruit plants distribution, and others programs.

One of SIDS's main objectives is to stand by flood victims and provide relief. The Sundarbans areas face natural calamities every year. The organization provided tarpaulins, dry ration, and cooked meal among the affected people of Bulbul, Amphan and Yaas
