Privacy Policy

Website Privacy:

We shall ask you to provide certain information by which you can be identified when using this website. Then you can be assured that it will only be used in accordance with this privacy statement. SIDS may change this policy from time to time by updating this page. This policy is effective from 01/04/2021.

What information do we collect?

When you visit our website you may provide us with Personal information you knowingly choose to disclose that is collected on an individual basis. We may request you voluntarily supply with personal information including email address, postal address, home or work telephone number and other personal information for such purposes as correspondence, placing an order, participating in an online surveys, etc. If you choose to correspond with us through email, we may retain the content of your email messages together with your email address. We provide the same protections for these electronic communications.

The information includes name, amount donated, address, telephone number, email address, donor comments and other personal information provided to us.

Information we collect and how we use it:

SIDS takes your privacy seriously and treats all financial information about any transaction as highly confidential. The organization deeply values all contributions to sustain our mission. To protect the privacy of our donors and their special relationship with SIDS, we maintain the following policies.

- To make sure we have an accurate record of all the donations that we have received.
- Maintaining an internal confidential database of all the personal information collected from visitors to the site.
- To email you with news and information about SIDS and our campaigns.
- To find out more about you and the people who are visiting our website, donating, joining our campaign.
- We seek personal information when you make a donation, request a communication from us, pledge support to our work and campaigns and apply for working or volunteering with **SIDS**.



- We will not use or release this information for any other purpose unless we have your consent.
- Within SIDS, access to personal information collected by SIDS will be given to only those persons who are authorized to SIDS.
- We may use the information to improve our products and services.
- SIDS does not sell, rent, trade or otherwise disclose personal information to our site visitors or our offline donors.
- SIDS reserves the right to disclose any personal information about you without notice or consent as needed to satisfy any requirement of law regulation, legal request or legal investigation, to protect SIDS and its property, to protect our visitors and other persons.
- From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone, fax or mail. We may use the information to customize the website according to your interests.
- We may collect information from you to extend services like for our internal purposes, for the purposes of administering our business activities, processing of your donations, providing receipts and tax exemption certificates, sending about regular updates about the developmental works, respond to your queries and apprising you of the new opportunities.

We might collect your name, address and payment method when you register on this website. We never collect your Credit card/Debit card number or Credit card/Debit card expiry date or other details pertaining to your Credit card/Debit card on our website. Credit card information will be obtained and processed by our online payment partner **Razorpay**.

Cookie policy:

We use cookies and other tracking mechanisms to track information about your use of our site and services. Cookies are small pieces of data that are stored by a user's web browser on the user's hard drive. These will be placed in your computer's hard disk and enables us to recognize you as a user when you next visit. A cookie in no way gives us access to your computer or any information about you other than the data you choose to share with us. You can choose to accept or decline cookies. If you disable the use of cookies on your web browser or remove or reject specific cookies from our website or linked sites then you may not be able to use the website as it is intended. Most web browser automatically accepts cookies, but you can usually modify your web browser setting to decline cookies, if you prefer.



How do we use information that is collected from Cookies?

We use cookies and web server logs to gather information about our website users' browsing activities, in order to constantly improve our website and better serve our customers. This information assists us to design and arrange our web pages in the most user-friendly manner and to continually improve our website to better meet the needs of our customers. This makes it easier for a user to move from web page to web page and to complete commercial transactions over the internet. Web server logs allow us to count how many people visit our website and evaluate our website's visitor capacity.

There are two types of cookies: session Cookies and persistent cookies. Session cookies exist only during an online session. They disappear from your computer when you close your browser or turn off your computer. We use session cookies to allow our systems to uniquely identify you during a session or while you are logged in to the site. Persistent cookies remain on your computer after you have closed your browser or turned off your computer. We use persistent cookies to track aggregate and statistical information about user activity.

We collect information from you passively:

We use tracking tools like Google analytics, Google webmaster, browser cookies and web beacons for collecting information about your usage of our website.
